Des Moines Conference to Explore the Role of Cities in Addressing Nuclear Threats and Global Warming

Des Moines, Iowa – Thursday, October 23, the **Office of the Mayor of the City of Des Moines**, **Mayors for Peace**, and **Drake University** will convene a one-day conference at Drake University entitled *Nuclear Abolition, Climate Protection, and Our Cities' Future*. The conference will take place in Sheslow Hall. Registration opens at 8:30; the *day program* is from 9:00 - 5:45. An *evening program* follows, from 7:30 - 9:00 pm. Admission is \$20; \$10 for the evening only; and is free to students.

"We think this is going to be a significant conference that will stimulate thought and action by mayors, city officials, activists, and members of the public," declared **Des Moines Mayor Frank Cownie.** "Iowa cities are among the nation's most active in sustainable energy initiatives. I'm pleased to be convening this landmark conference in cooperation with Drake University and Mayors for Peace."

In Iowa and across the country, cities are taking actions to protect the climate. Over 850 mayors have signed the U.S. Conference of Mayors Climate Protection Agreement.

Cities also are stepping up to the threat to our future posed by nuclear weapons, still possessed in very large numbers by nine countries including the United States. A resolution adopted this year by the U.S. Conference of Mayors calls upon the federal government to work for the worldwide elimination of nuclear forces by 2020. 130 U.S. mayors are members of Mayors for Peace, a rapidly growing international network dedicated to the abolition of nuclear weapons. Headed by the mayors of Hiroshima and Nagasaki, Mayors for Peace has over 2,400 members in 131 countries.

Mayors for Peace North American Coordinator Jacqueline Cabasso explained: "This conference is the first U.S. Mayors for Peace regional meeting, and it seeks to break new ground in exploring the linkages between nuclear weapons and climate change, and the role of cities in addressing these twin challenges to our very survival."

The *morning session* will present the case for peace and sustainable energy. Panels will examine climactic effects of use of nuclear weapons, international frameworks for cooperation

on nuclear abolition and climate protection, climate-friendly energy paths, the emerging alternative of wind power, and the role of nuclear power. Featured speakers include: **Steven Starr**, MT, Senior Scientist, Physicians for Social Responsibility; **Dr. John Burroughs**, Lawyers' Committee on Nuclear Policy; **Dr. Jürgen Scheffran**, University of Illinois, Urbana-Champaign; **Pat Spears**, Intertribal Council on Energy Policy; and **Dr. Brice Smith**, State University of New York, Cortland.

The *afternoon session* will explore social change and the role of cities. Panelists will discuss converting the militarized economy and the broader context of changing urban priorities. Featured speakers include: **Mary Beth Sullivan**, Global Network Against Weapons and Nuclear Power in Space; **Wilson Riles**, former Oakland, California city council member; and **Andrew Lichterman**, Western States Legal Foundation. Des Moines Mayor **Frank Cownie**, Fairfield Mayor **Ed Malloy**, and Indianola Mayor **Jerry Kelley** will discuss the role of cities.

The *evening program*, "Nuclear Abolition and Climate Protection: Whys and Ways," features two leaders in analysis and action: Dr. Arjun Makhijani, President, Institute for Energy and Environmental Research, and author, *Carbon-Free and Nuclear-Free: A Roadmap for U.S. Energy Policy* (2007); and Ms. Jacqueline Cabasso, North American Coordinator, Mayors for Peace, Executive Director, Western States Legal Foundation, and contributing author, *Nuclear Disorder or Cooperative Security? U.S. Weapons of Terror, the Global Proliferation Crisis, and Paths to Peace* (2007). Ed Fallon, IMforIowa, will moderate.

The conference is being organized by Lawyers' Committee on Nuclear Policy, Western States Legal Foundation, Global Action to Prevent War, in association with Mayors for Peace; and Progressive Coalition of Central Iowa. It has the support of 19 co-sponsoring community based organizations.
